### Workshop description

The workshop objectives are to take stock of the research findings, and to identify ways of moving forward towards consistent and common final research outputs – which would allow the VULNER consortium members to contribute to existing academic and policy debates on the consequences, challenges and pitfalls of the increased reliance on 'vulnerability' as a key legal and policy concept in EU migration law and policy.

The discussions on September 22, 2022 will focus on the research findings, as part of two panels that will reflect the VULNER project's geographical diversity:

- A first panel will discuss how and under which conditions 'vulnerability' assessments can support the design and implementation of humanitarian protection programmes that benefit refugees in the Global South, in a way that better considers and responds to their actual protection needs. It should allow us to get back to 'vulnerability' very first meanings and functions as a humanitarian concept. It will also make a connection with current debates on resettlement programmes, and how 'vulnerability assessments' could be improved to guarantee effective access to protection for the most vulnerable refugees.
- A second panel will address the use of vulnerability assessments as part of asylum and border processes. It will allow the workshop participants to debate on the added value and risks of such assessments in terms of refugee protection (including how they relate with international refugee law standards), based on the analysis of the main life challenges encountered by asylum applicants during these processes and of the extent to which they hinder access to protection.

In the evening, a public event will take place as part of the VULNER talk series. The objective will be to take stock of the evolutions of EU migration and asylum law and policy since the adoption of the EU New Migration Pact on Asylum and Migration, while focusing on the uses of 'vulnerability' to guide and/or legitimize the adopted measures.

The discussions on September 23, 2022 will be focused on the way forward for establishing the final and common book publication. In the morning, the workshop participants will reflect on how the COVID pandemic impacted the data collection process and the research participants' experiences. In the afternoon, the VULNER consortium members will discuss the final book publication's layout.
